## Intent of the Concurrent Sessions

The primary aim of the Conference is to provide a platform for gathering and disseminating important mining health and safety information. This includes information from the industry itself, such as incidents and their causes, hazard controls and innovative solutions to health and safety issues. It also includes information and innovation developed outside the industry, challenging perceptions of how things can best be done in the resources sector.

There are no limitations as to where good ideas may originate. We need to share all the relevant information we collect and be open to fresh ideas using the information collected by others.

The Concurrent Sessions should seek to impart health and safety information in keeping with the purpose of the Conference.



## Suggested Topics



**Implementing the Hierarchy of Controls** – An opportunity to showcase advances in, and adaptation of, systems and technology that has or could improve health and safety in mining.

**Vehicle Interactions** – Limiting the risks associated with vehicle to vehicle, vehicle to infrastructure and vehicle to people interactions.

**Research and Application** – What has recent evidence-based research taught the mining industry, and most importantly, how can it be practically applied to achieve positive health and safety outcomes in the industry?

**Physical and Psychological Well-being** – Recognising and managing health issues such as substance abuse, fatigue, the impacts of FIFO, common societal health and disease concerns.

**Occupational Hygiene** – Understanding the contaminants and adverse health determinants within our industry and preventing impacts on human health.

**Behavioural and Systems Based Safety** – What we can learn from applying behaviour-change science to approach workplace safety and health problems?

**Training and Competency** – The methods and application of effective workplace education and training to improve safety and health.

**HPI and Accidents Share** – An opportunity for blame-free information sharing on what has gone wrong and how it can be prevented from reoccurring.

**Management Structures** – How mines develop, maintain and document the management structure to allow for effective safety and health management.

**Managing Contractors on Mines** – A group over-represented in serious accidents and fatalities in the industry.

**Tyre and Rim Management on Mines** – Hazards associated with tyres, rims and wheel assemblies and the need to manage these safety critical items to minimise risks to the safety of workers - a significant source of fatal injuries in the industry.

**Safety Leadership** – What makes a good safety leader.

### Additional Important Information:

Our aim is that delegates should come away from the Conference armed with practical information on improving health and safety in their work place.

- The abstract **MUST** cover issues of relevance to occupational health and safety within the Queensland Resources Industry.
- The abstract **MUST** reflect the content of the oral presentation and the written paper.
- The presentation **MUST NOT** be of a commercial nature or directly advertise or promote commercial products or services.

### Preference will be given to those presentations which include at least some of the following:

- practical advice that leads to achievable actions for improving health and safety;
- improvements to outcomes while maintaining current levels of resourcing;
- making best use of currently available systems, products and services in an innovative way;
- understanding which activities, systems, products and services that the industry is currently using or has available to it that really do make a positive contribution to health and safety improvements;
- information that is of value to individuals at all levels of business;
- provide attendees with practical and achievable ideas that they can use when they return to their workplace.

### Successful Presenter **MUST AGREE** to:

- Make an oral presentation for up to 20 minutes at the Conference and be prepared to take questions from the audience for up to an additional 5 minutes.
- Register as a delegate to attend the Conference. [A concession on the Early Bird Registration Fee is offered to one presenter for each presentation.](#)
- The presentation being video recorded, synchronised to the PowerPoint presentation and placed on the Conference website. Provision has been made for you to liaise with the recording contractor to amend any of your PowerPoint slides.
- Cover own cost of travel and accommodation.
- The option to prepare a \*written paper\* up to a maximum of 10 x A4 pages for submission by **Friday 27 August 2021** to the Conference Organiser for publication on the Conference website after the Conference.

## Paper Abstract Guidelines

### SPECIFICATIONS

- **The Abstract** (excluding headings): MUST NOT exceed 200 words in length.  
If accepted, this abstract (as submitted) will be published in the Conference Handbook.
- **Format:** Microsoft Word.
- **Font:** Arial
- **Page:** Company logos, photos or designs **are not** to be shown on the page.
- **Heading 1** Title of Presentation as it will appear in Program if successful (18pt Bold, justified to the left of the top of the page in upper and lower case – NOT UPPER CASE).  
**The presentation title must not exceed 50 characters, including spaces.**
- **Heading 2** Presenter/s: Given and Surname/s of the Presenter/s – no titles etc. (16pt Bold justified to the left of the page in upper and lower case – NOT UPPER CASE).
- **Heading 3** Author/s: Given and surname of Author/s – no titles etc. (16pt Bold justified to the left of the page in upper and lower case – NOT UPPER CASE).
- **Heading 4** Organisation: Name of Organisation/s (16pt Bold justified to the left of the page in upper and lower case – NOT UPPER CASE).
- **Text** The rest of the text for the Abstract must be in 12pt, sentence case, single line spacing with double spacing between paragraphs.
